## **1.1 PURPOSE**

The Tenderer, however, is at liberty to add further details that he may deem desirable. Such details shall not be binding upon the Purchaser.**
- **RANKING SYSTEM. The Schedule for technical requirements includes a checklist ranking system marked M, S or C with their meanings as explained hereunder.**

*M – Must have. This means that specifications included in the section are fixed and no compromises will be made. Specifications from supplier must conform to any specifications written in this section.*

*S – Should have. This means that specifications by the supplier should conform to the requested specifications. However, here the supplier may offer a specification or solution which will perform or is equal to the requested specification and is acceptable by Enemalta Corporation.*

*C – Could have. This includes specifications that the item is “nice to have” and if price was competitive could influence the final decision. Since this is not a must and not a should, if this is not in the specification this may be chosen. If the final decision is one of price than the one which offered the “Could Have’s” will be given preference.*

*The prospective tenderer must ensure that as a minimum the “must have’s” are ALL COMPLETED.. This should also give the option to the prospective tenderers to offer alternative and possibly more technically and cost effective solutions by conforming to the “must have” and possibly offering variations for the others.*
